CLIENT CONTRACT

*****PLEASE READ AND INITIAL EACH SECTION*****

This is a contract between Dogwood Kennels, Inc and the pet(s) Owner(s) whose initials and signature appear below.

Owner agrees to pay all charges in effect by the date pet(s) are picked up. For Long term boarding stays, owner agrees to pay a deposit at drop off and pay bill in full at time of checkout. Owner further agrees to pay all costs and charges for additional services requested or required. If pet(s) is not picked up 60 days after said departure date and no contact has been made between Owner and Dogwood Kennels, Inc Dogwood Kennels, Inc reserves the right to rehome pet(s).

For the safety of Owner(s) pet(s) as well as others, all pet(s) must enter and exit premises on a leash or safely contained in a pet carrier. All pet(s) must have a reservation/appointment prior to attending boarding, daycare, and/or grooming.

Owner agrees that pet(s) vaccines are up to date, including, Rabies (1 or 3-year vaccine required), DPP (Distemper, Parvovirus & Parainfluenza) 1 or 3-year vaccine required. Bordetella (Canine Cough) required every 12 months, and at least 48 hours prior to check-in. Negative Fecal exam (annual). Owner acknowledges it is their responsibility to update pet(s) records with Dogwood Kennels, Inc when necessary. Owner agrees to hold Dogwood Kennels, Inc harmless for any illness relating to their pet(s) lack of proper vaccinations. Owner understands that Dogwood Kennels, Inc refuses to take any pet(s) into their care that are not up to date on their Rabies vaccinations per Massachusetts state law. Owner understands pet(s) with fleas or ticks will be bathed/treatment at owners' expense.

Owner(s) with pet(s) that are boarding and/or daycare, understands the risks including, but not limited to physical injury, escape, exposure to other animals and elements. Pet(s) allowed to interact with other dog(s) (permission by Owner ONLY), owner understands and acknowledges that even under the strictest supervision, pet(s) is at risk to incidents including but not limited to bites, fights, scratched and cuts during playtime and while interacting with other dog(s).

Owner understands pet(s) may be lethargic after returning home from Dogwood Kennels, Inc due to amount of playtime and stimulation pet(s) receive while in Dogwood Kennels, Inc care. Pet(s), even ones that are not allowed interaction with other dog(s), may become lethargic due to but not limited to, length of pet(s) stay, medical history, separation anxiety etc. Owner understands pet(s) may contract canine colds and or illness.
